# Policy Principles/Aims:

At Bede's, social interaction and integration is encouraged to allow everyone to feel part of the school community. Language learning takes place both inside and outside the classroom. #### • Behaviour Policy 2025

#### 1. Eastbourne and Windlesham Centres

- I. Students' mobile phones must be given to centre staff on arrival. They will be kept in a secure locked location. Students are given allocated times during the day to use their mobile phones to call home. Students are not allowed to carry their phones around the campus or to take them back to the boarding houses.
- II. Students are allowed to take their mobile phones on excursions but they are encouraged to put their phone away when not using it for taking photos, for example. Students should use their phone responsibly and staff are permitted to take a student's phone for safekeeping, if they consider it to be in the student's best interests.

#### 2. Dicker and Royal Russell Centres

- I. Students are not permitted to carry mobile phones with them around campus. Students must keep their phones in their bedrooms, which are locked. However, if rooms are not able to be locked, padlocks will be provided for lockable cupboards if needed. In the case that students are unable to call home in the morning or evening due to time differences, the centre will make an allowance for this. In an emergency, the centre staff will make the call if a student's mobile is not accessible. Students are not permitted to return to their boarding houses during lessons, break or lunch times, or activity times to use their mobile phones.
- II. Students are permitted to use their phone during free time in the evening and to take their mobile phone on excursions. Students should use their phone responsibly and staff are permitted to take a student's phone for safekeeping, if they consider it to be in the student's best interests.

#### 3. Lancing and Brighton Centres

I. Students are allowed to use their mobile phones on campus. They are responsible for them, and should use as stated below:

#### <u>Lessons</u>

Students' mobile phones must be switched off and put away during lessons.

# Activities

Students may not carry their mobile phones to activity sessions unless advised to do so by their Activity Leader.

#### <u>Meals</u>

Mobile phones should not generally be used at meal times unless necessary.

#### Free time, Social Events, Excursions

Mobile phones may be used during social events on campus, on excursions, and during free time.

# 4. Exemptions to the policy

- At Bede's Summer School, we understand that there may be exceptional circumstances where students need to use their mobile phones outside of the designated times outlined in our Student Mobile Phone Usage Policy. Exemptions can be granted on a case-by-case basis for reasons such as:
  - **medical reasons**, such as managing a health condition with a monitoring app or needing to contact medical professionals quickly;
  - **welfare reasons**, such as phone access for ongoing support from a mental health professional or counsellor, or to stay connected with family for emotional support;
  - family emergencies, such as urgent family matters such as illness or bereavement,
  - **special educational needs**, such as to support a student's learning with apps, learning resources or communication tools.
- Requests for exemptions with supporting documentation if required should be made in advance to the Summer School Admissions Team, and approval will be given only when deemed appropriate. We encourage all students to respect the policy while enjoying their time at Bede's Summer School and to use mobile phones responsibly when exemptions are granted, to minimise disruption to the learning environment for all students.
