## **Finding Us**

If you are coming to us by road, the University is on the A27at Falmer between Brighton and Lewes about four miles (six kilometres) from the centre of Brighton. The postcode is **BN1 9QU**. There is various parking lots on campus but charges apply. Once parked, find your way to Bramber House where Bede's Summer School office is located on the 2<sup>nd</sup> floor.

By rail, frequent trains from London to Lewes operate, where you can change for Falmer. Falmer train station is directly opposite the University and pedestrian access is through a subway under the A27.

If coming to us by the Channel Tunnel, Ashford international train station terminal is approximately 1 hour and 30 minutes away by road.

Please follow the speed limits when driving on campus and remember that use of mobile phones while driving is strictly prohibited.
